

## **NCPS Members Meeting February 25, 2007**

Ron read minutes from last Board meeting.

Treasurer report (after paying this month's expenses) \$3,676.68 plus \$8.00 in refrigerator box.

### **New business**

Serious issues to be written into bylaws.

John – Qualifications to be a member. In the past only \$20.00 to be a member. Should be a USPSA member within 90 days or suspend membership until they are a USPSA member. Would only affect 1 to 2 people in the club.

Cathy – we now have 7 members that are not USPSA members.

Butch – may have liability since we can not police it.

This should be moved to the bylaws section on removal from club.

**Training new shooters** – John – brief shooters orientation is inadequate. Officers are busy before match starts. Need a new qualified trainer with checklist of what to discuss.

Bob Hodges – don't want to see people not being able to shoot.

Assign an experienced shooter to mentor new shooters.

Alex has a check list, John to check with him.

Targetmasters has new shooters training, 9 – 2pm during setup before match. First in class then go thru range practice.

CAPSL only uses 3 bays, 2 are available for training.

NCPS could hold Saturday training – check on bay availability.

Need volunteer for training.

Put new shooter info on web site.

Butch maintains web page with videos.

### **Access to range equipment.**

Only two people have signed out the key.

FSC is attacking NCPS members shooting by themselves. This has come up at FSC meetings. Shooters must be a FSC member to shoot alone.

John – looking for higher authority, USPSA-NROI, RO or above

NCPS requirement – to be FSC member, NCPS member, NROI RO or above to shoot solo (proposed)

### **Monthly publication – Jack's Tracks**

Change to monthly e-mail. Still have a few people who don't use Internet. Allow snailmail for them or people who e-mail accounts are not accessible.

### **Number of Board Members**

7 BOD Members, 41 current NCPS members.

Five officers with defined duties, two directors represent shooters. Jared – now a director, working on re-writing the bylaws. Can't sustain seven Board members.

Proposal to have variable number of Board members or allow loser to take a vacant seat – Not acceptable.

Can have committees to work on tasks with at least one Board member on committee.

John – like to cut to five Board members, eliminate the Director positions.

**Second Saturday Shoot** – Limited match from bylaws. Propose to strike from bylaws.

### **New Business**

Butch – purchases not made by previous Board. Timers and Chronos. Need consumables – paint, screws, cables, crimpers.

Need inventory of equipment.

Dimensions of bays – Butch has them, Jared may measure.

### **Range Expansion Project**

Blueprints are done, stakes are out there.

Need to plan for water, power requirements, drainage.

If members wish to piggyback on club orders (targets, equipment, etc.) it is OK.
